

# St. Mary PPA Scrip FAQs

## When Can I Order?

We generally order every 2 weeks, depending on the amount of orders we have, and more weekly during peak times (holidays, end of school year). Here is our anticipated schedule for the remainder of 2015.

<b>Mon., December 5</b>	Friday, December 9
<b>Mon., December 12</b>	Friday, December 16
<b>Mon., December 19</b>	Friday, December 22

Orders received after a listed order date will be held until the next order is placed. In the event that you need cards by a certain date, please make sure to let us know when you order so that we can inform you right away if we cannot meet that date.

If there are any changes to this schedule, we will send a notification to families via an e-mail to the PPA mailing list.

## Can I Get ... ?

Please check our order form, which is kept up to date and sent home periodically in your blue folder. It is also available on the PPA Web site. If you don't see something you are looking for on there, check [www.glscrip.com](http://www.glscrip.com) and click "Retailer List" at the bottom of that page for a complete list of cards that are available to order.

## Can I Buy Cards at School?

We will be set up outside to sell cards prior to afternoon dismissal on the dates on which deliveries are scheduled. Please refer to the chart above for these dates. You can also pick up orders at that time, if you prefer not to have them sent home through school. Cards can also be purchased in person at scheduled PPA meetings and selected events.

## Do the Gift Cards Expire?

No! These are exactly the same as cards you would purchase at retail outlets. There are no activation or convenience fees, and cards do not expire.

## Can I Pay with a Credit Card?

Unfortunately, we can't accept credit cards for payment. In many cases, the fee we would have to pay the credit card company to maintain an account and accept payments would exceed the rebate we earn. Obviously, this doesn't work out too well when trying to operate a fundraiser! Payment can be made via cash or check made payable to St. Mary PPA. You can also sign up for PrestoPay, which allows you to pay electronically via debit from your bank account. Details are available online or on request.

## What Cards Do You Have in Stock?

For last-minute gifts, extra cards between orders, and so on, these are cards we currently stock:

- \$5: Panera, Barnes & Noble, Starbucks

You can get these cards through "school mail" or at any of our Scrip Shop dates. Remember that our inventory is first come, first served. Payment is due at time of purchase.
