Within the next few weeks, you will receive an email from Smart Tuition welcoming you to tuition billing for 2017-2018. The email will be sent to the email address that is currently associated with your Smart account – *for new families this will be the email used to register in TADS*. Please make sure to check your SPAM folders as some email providers may filter out emails from Smart until you add them to your contacts. Upon receipt, you will be prompted to log in and review your 2017-2018 Smart Tuition billing account and its associated settings.

All tuition and fee payments must be made directly through Smart Tuition and cannot be remitted to the school. For your reference, attached is a summary schedule of school tuition and fees.
